

Privacy Statement

A&G Healthcare Services is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the A&G Healthcare Services Web site and governs data collection and usage. By using the A&G Healthcare Services website, you consent to the data practices described in this statement.

Collection of your Personal Information

A&G Healthcare Services collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. A&G Healthcare Services also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by A&G Healthcare Services. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by A&G Healthcare Services for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the A&G Healthcare Services Web site.

Use of your Personal Information

A&G Healthcare Services collects and uses your personal information to operate the A&G Healthcare Services Web site and deliver the services you have requested. A&G Healthcare Services also uses your personally identifiable information to inform you of other products or services available from A&G Healthcare Services and its affiliates. A&G Healthcare Services may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

A&G Healthcare Services does not sell, rent or lease its customer lists to third parties. A&G Healthcare Services may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, A&G Healthcare Services may share data with trusted partners to help us

perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to A&G Healthcare Services, and they are required to maintain the confidentiality of your information.

A&G Healthcare Services does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

A&G Healthcare Services keeps track of the Web sites and pages our customers visit within A&G Healthcare Services, in order to determine what A&G Healthcare Services services are the most popular. This data is used to deliver customized content and advertising within A&G Healthcare Services to customers whose behavior indicates that they are interested in a particular subject area.

A&G Healthcare Services Web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on A&G Healthcare Services or the site; (b) protect and defend the rights or property of A&G Healthcare Services; and, (c) act under exigent circumstances to protect the personal safety of users of A&G Healthcare Services, or the public.

Use of Cookies

The A&G Healthcare Services Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize A&G Healthcare Services pages, or register with A&G Healthcare Services site or services, a cookie helps A&G Healthcare Services to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. Security of your Personal Information

A&G Healthcare Services secures your personal information from unauthorized access, use or

disclosure. A&G Healthcare Services secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other Web sites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.
